Ray recommends taking down both trees since both are dying and replacing with landscaping rock. Megan Ferguson asked if it was necessary to cut both trees down. Jess will confirm with Ray to see if one or both trees are in danger of damaging the neighbor's property. LHA will email the board when LHA receives the quotes and ask for guidance.
